

**STRATFORD CITY COUNCIL
REGULAR MEETING
January 14, 2019**

The Stratford City Council met for a budget work session on Monday, January 14, 2019, with Mayor Larry Runyan calling the meeting to order at 6:30 p.m. at City Hall.

Council members answering roll call were: Randy Baker, Heather Conklin, Chase Haman, and Mitch Peterson. Council member Justin Richardson was absent. Also present was Kim Leeds, Dan Ostrem, and City Manager Amanda Westrum.

Council and City Manager Westrum reviewed Capital Improvement Plan and Fiscal Year 2020 Budget.

The Stratford City Council met in regular session on Monday, January 14, 2019, with Mayor Larry Runyan calling the meeting to order at 7:00 p.m. at City Hall and leading the Pledge of Allegiance.

Moved by Baker, seconded by Haman to approve the tentative agenda. Roll call vote: Baker – aye, Conklin – aye, Haman – aye, Peterson – aye. Motion carried.

Moved by Haman, seconded by Peterson to approve previous meeting minutes from December 10, 2018. Roll call vote: Baker – aye, Conklin – aye, Haman – aye, Peterson – aye. Motion carried.

Moved by Conklin, seconded by Peterson to approve the consent agenda as follows: Financial Report for December 2018, Current Claims since Previous Council Approval for \$19,807.65, and Delinquent Utility Account Report. Moved by Peterson, seconded by Haman to approve Resolution 2019-09 – a resolution approving mayoral appointments and organization board member approvals for calendar year 2019. Roll call vote: Baker – aye, Conklin – aye, Haman – aye, Peterson – aye. Motion carried.

Moved by Haman, seconded by Peterson to approve Library budget request for Fiscal Year 2020 with permissible levy request for \$2,500, special levy request for \$3,115, and general (8.10) levy request of \$26,582 with the total City tax levy approved at \$32,197. Roll call vote: Baker – aye, Conklin – aye, Haman – aye, Peterson – aye. Motion carried.

Moved by Haman, seconded by Peterson to approve the Fire Department budget request for Fiscal Year 2020 with special levy request for \$8,450; permissible levy request for \$8,050, and the general tax levy request for \$10,995.25 with the total City tax levy approved at \$27,495.25. Roll call vote: Baker – aye, Conklin – aye, Haman – aye, Peterson – aye. Motion carried.

Moved by Baker, seconded by Conklin to approve the Rescue Department budget request for Fiscal Year 2020 with permissible levy request for \$8,775, and special levy request for \$8,300 with the total City tax levy approved at \$17,075. Roll call vote: Baker – aye, Conklin – aye, Haman – aye, Peterson – aye. Motion carried.

City Manager Westrum reviewed utility fund rates and potential utility budget for Fiscal Year 2020. It was suggested that the utility fund rates remain the same for Fiscal Year 2020.


