

**STRATFORD CITY COUNCIL
REGULAR MEETING
July 11, 2022**

The Stratford City Council met in regular session on Monday, July 11, 2022, with Mayor Larry Runyan calling the meeting to order at 7:00 p.m. at City Hall and leading the Pledge of Allegiance.

Council members answering roll call were: Carol Bergman, Catherine Bergman, Terry Bryan, Ht Buie, and Brian Ouverson. Also present were Chris Kehoe with The Trash Man, Toni Larson, Dan Ostrem, Maddy Daniels, and City Manager Kim Leeds.

Moved by Catherine Bergman, seconded by HT Buie to approve the tentative agenda. Roll call vote: Carol Bergman – aye, Catherine Bergman – aye, Terry Bryan – aye, Ht Buie – aye, Brian Ouverson – aye. Motion carried.

Moved by Ht Buie, seconded by Carol Bergman to approve previous meeting minutes from June 13, 2022. Roll call vote: Carol Bergman – aye, Catherine Bergman – aye, Terry Bryan – aye, Ht Buie – aye, Brian Ouverson – aye. Motion carried.

Moved by Terry Bryan, seconded by Brian Ouverson to approve the consent agenda as follows: Financial Report for June 2022, Current Claims since Previous Council Approval for \$32,323.78, Oakwood Cemetery Donation of \$5,000.00, and Delinquent Utility Account Report. Chris Kehoe from the Trash Man was present to discuss the Trash Man bid with council and give council some background on their company. The Trash Man has been in operation for the last thirty-five (35) years. They currently provide garbage services to about thirty-three (33) cities, with twenty-five (25) trucks on the road every day. The cost of residential garbage and recycling per month is \$20.42. The Trash Man will honor our clean-up day as it currently is. Waste Management will be present at the next regular council meeting on August 8th, 2022, to present their bid to council. Council will discuss at the September regular meeting and make a final decision in the following months.


