## Ordinance Change on additional fees

City council for the City of Stratford has passed an Ordinance for water with a few additional changes. The changes that will be included are fees. A \$50.00 fee will be accessed for any door notice. If the account is disconnected of \$50.00 plus \$20.00 trip fee will be accessed to the delinquent or disconnected account. If the account is re-connected a fee of \$75.00 plus \$20.00 trip fee will be accessed during regular business hours and \$100.00 after regular business hours shall be charged before service is restored to a delinquent customer. No fee shall be charged for the usual customary trips in the regular changes in occupancies of property.

## DEFINITIONS

- Maximum Contaminant Level (MCL) – The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- Maximum Contaminant Level Goal (MCLG) -- The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- ppb -- parts per billion.
- ppm -- parts per million.
- pCi/L – picocuries per liter
- N/A – Not applicable
- ND -- Not detected
- RAA – Running Annual Average

- Treatment Technique (TT) – A required process intended to reduce the level of a contaminant in drinking water.
- Action Level (AL) – The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- Maximum Residual Disinfectant Level Goal (MRDLG) - The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- Maximum Residual Disinfectant Level (MRDL) - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- SGL – Single Sample Result
- RTCR – Revised Total Coliform Rule
- NTU – Nephelometric Turbidity Units

## GENERAL INFORMATION

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water posed a health risk. More information about contaminants or potential health effects can be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline (800-426-4791).

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. STRATFORD MUNI WATER DEPT is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. ## ADDITIONAL HEALTH INFORMATION

This is an alert about your drinking water and a cosmetic dental problem that might affect children under nine years of age. At low levels fluoride can prevent cavities, but children drinking water containing more than 2.0 milligrams per liter (mg/l) of fluoride may develop cosmetic discoloration of their permanent teeth (dental fluorosis). The Drinking water provided by our public water system has levels above 2.0 mg/L, but below 4.0 mg/L (see chart).

Dental fluorosis in its moderate or severe forms, may result in a brown staining and or pitting of the permanent teeth. This problem occurs only in developing teeth, before they erupt from the gums. Children under nine should be provided with alternative sources of drinking water or water that has been treated to remove the fluoride to avoid the possibility of staining and pitting of their permanent teeth. You may also want to contact your dentist about proper use by young children of fluoride-containing products. Older children and adults may safely drink the water.

Drinking water containing more than 4.0 mg/l of fluoride (the U.S. Environmental Protection Agency's drinking water standard) can increase your risk of developing bone disease. Your drinking water does not contain more than 4.0 mg/l of fluoride, but we're required to notify you when we discover that the fluoride levels in your drinking water exceed 2.0 mg/l because of this cosmetic dental problem.

Your water supplier can lower the concentration of fluoride in your water so you will still receive the benefits of cavity prevention while the possibility of stained and pitted teeth is minimized. Removal of fluoride may increase your water costs. Treatment systems are also commercially available for home use. Information on such systems is available at the address given by your public water supplier. Low fluoride bottled drinking water that would meet all standards is also commercially available. Some home water treatment units are also available to remove fluoride from drinking water. In Iowa, home water treatment units are regulated under 641-Chapter 14, with the water treatment unit registration program administered by the Iowa Department of Public Health's environmental health division. In addition, you may call the national Sanitation Foundation (NSF) International, at 1-877-867-3435.

## SOURCE WATER ASSESSMENT INFORMATION

This water supply obtains its water from the limestone and dolomite of the Mississippian aquifer. The Mississippian aquifer was determined to have low susceptibility to contamination because the characteristics of the aquifer and overlying materials provide natural protection from contaminants at the land surface. The Mississippian wells will have low susceptibility to surface contaminants such as leaking underground storage tanks, contaminant spills, and excess fertilizer application. A detailed evaluation of your source water was completed by the Iowa Department of Natural Resources, and is available from the Water Operator at 515-838-2311.

## PUBLIC NOTICE

The City of Stratford staff would like to inform the citizens of Stratford that maintenance staff will continue cutting down dead and dying trees **in the city right of way** and **on city owned property** due to Emerald Ash Borer disease.

The City has a Tree Plan, The City plans to take down 14 more trees this summer and fall. ### SEASONAL REMINDERS

The Stratford Public Works Department would like to remind residents **not to blow grass, leaves**, or other debris into the street. These can potentially cause clogging of the storm sewers which may result in flooding and can result in costly repairs which are ultimately paid for by the tax payers. Rain waters push grass, leaves and other debris that have blown into the street, down the curb line and into the storm drains. Stratford's Code of ordinance is as follows:

**135.03 PLACING DEBRIS ON.** It is *unlawful* for any person to throw or deposit on any street or alley any glass, glass bottle, nails, tacks, wire, cans, trash, garbage, rubbish, litter, offal, ***leaves, grass*** or any other debris likely to be washed into the storm sewer and clog the storm sewer, or any substance likely to injure any person, animal or vehicle.  
(Code of Iowa, Sec. 321.369)

Storm drains and storm sewers need to remain clear of grass, leaves, and other debris to allow storm waters to leave your area and drain out through the storm sewer system rather than backing up and causing flooding in your area.

If you have grass clippings and yard debris the city has a **yard waste only** site for the citizens of Stratford. Come up to City Hall and ask for a key to access the City owned debris site. Anyone living within Stratford's city limits may take **yard debris, grass clippings, leaves and small branches no larger than 4 inches in diameter**, to the site.

- **Remember to recycle!** There are items that must not be put into a recycling bin. Your recycling will not be picked up if a "no-no" is in your recycling bin. City Hall has a list of items that can and cannot be recycled. - **Electrical Outage Procedures** If experiencing an electrical power outage during City Hall's business hours of 8:00 – 4:30 p.m., call 515-838-2311. When experiencing an electrical power outage after hours at your place of residence, call Maintenance Supervisor Brad Larson at 641-373-7676. If the whole town is experiencing an electrical power outage and Maintenance Staff doesn't answer, call Hamilton County Dispatch at 515-832-9500; or Midland Power Cooperative's emergency number, 1-800-286-2268. If all else fails, call 911.
- **Spring Clean-Up Day** is Saturday, May 3<sup>rd</sup> starting at 7 AM. Please contact City Hall if you are needing more information on what you can and can't set out.
