STRATFORD CITY COUNCIL REGULAR MEETING November 11, 2024

The Stratford City Council met in regular session on Monday, November 11, 2024, with Mayor Brian Ouverson calling the meeting to order at 7:00 P.M. at City Hall and leading the Pledge of Allegiance.

Council and City Manager Leeds had a short discussion regarding the United Cooperative's request for tax exemption on the new construction of two bins and a load out. Leeds explained that the values for this new construction will not be available thru the accessor's office until mid-January of 2025.
